

ECONOMIC ANALYSIS MODULE

Goal

At the completion of this session the participant will be able to determine and demonstrate whether an article about an economic analysis of a specific therapy or health intervention has drawn conclusions about the efficiency that are both valid (true) and applicable (sensible or feasible) in one's own clinical practice.

2. understand and explain; cost minimization analysis, cost effectiveness analysis, cost utility analysis, and cost benefit analysis
3. determine the applicability of a economic analysis to a particular situation.
